FIRST AID

ALLIGARE BLACK POND DYE is a non-toxic, environmentally safe dye meant to beautify ponds while imparting the added benefit of reducing sunlight penetration while giving the surface water a deeper, more natural looking appearance. It will not harm fish, waterfowl, pets or wildlife. Fishing, swimming and other water activities may occur immediately following application.

Color vibrancy will gradually fade due to sunlight, adjustments to the water volume, or chlorinated treatment products and will require the addition of more product.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING.

For application to ponds and ornamental bodies of water.

Calculate total volume in your body of water into Gallons or Acre-Feet.

Length (ft) x Width (ft) x Avg. Depth (ft) x 7.5 = Gallons

Length (ft) x Width (ft) x Avg. Depth (ft) / 43,560 = Acre-Feet

Apply at one gallon per four (4) acre feet or 1,300,000 gallons of water.

Apply to water, directly from container, along shoreline or from a slow moving boat for larger bodies of water. Alligare Black Pond Dye can also be applied to the water inlet or in spot treatments across the entire body of water. Approximately twenty-four (24) hours later, the entire body should have a uniform appearance due to natural wind and water currents. If a deeper color is desired, add additional dye and allow at least 24 hours before further applications. Apply early in the year (Spring), then apply again, as needed, throughout the year to maintain color intensity. Do not apply before or immediately following heavy rainfall events that could result in an overflow situation.

SPILLS

If a spill occurs, soak up as much dye possible with disposable absorbent materials. Immediately follow with bleach to the affected area to try and prevent unwanted, long-term stains.

STORAGE AND DISPOSAL

STORAGE: Store in a cool well-ventilated place. Do not store near heat or open flame. Keep in original container tightly closed. Do not reuse empty container. For optimal storage, store between 40° and 90° F.

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste disposal facility in accordance with all federal, state and local regulations. Triple rinse (or equivalent) adding rinse water to application tank. Offer container for recycling or dispose of in a sanitary landfill or by other procedures approved by local regulations. If burning is allowed, stay out of smoke. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
