GENERAL INFORMATION – Alligare Pattern reduces drift risk and maximizes pesticide performance by binding Ultra Small Spray Particles together into larger droplets which are more capable of hitting their intended target. Alligare Pattern's refined use rates and low "phase out" formulation make it the easiest to use liquid drift retardant.

DIRECTIONS FOR USE – The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using Alligare Pattern, the applicator or crops advisor must have experience with the pesticide combination, including Alligare Pattern, or must have conducted a phytotoxicity test.

SHAKE WELL BEFORE USING.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NONCROPLAND, ORNAMENTAL, RIGHTS-OF-WAY, TURF AND OTHER APPROPRIATE USES.

USE RATES – As a general guideline, use 1-4 ounces per 100 gallons of spray solution. Always start with the lower dosage and increase as needed to address specific spray conditions. If spray fines are not eliminated, add additional quantities of Alligare Pattern in 1-ounce increments until desired results are achieved.

MIXING – In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order: 1) Compatibility agent and/or antifoam, if needed. 2) AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants. 3) Dry soluble and suspension fertilizers / micronutrients. 4) Liquid drift retardants and flowable formulations (F & FL). 5) Liquid concentrates, suspension and microencapsulated (LC, SC, ME). 6) Emulsifiable concentrates (E, EL or EC). 7) Solutions and soluble liquids (S or SL). 8) Liquid micronutrients and fertilizers. 9) Water conditioners and other adjuvants (COC, HSOC, MSO, NIS). 10) Finish filling to desired spray volume level and continue agitation.

STORAGE AND DISPOSAL - If product freezes, warm to room temperature before use. Keep containers sealed when not in use. Prevent water from being introduced into the contents of this package. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of

container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
