ALLIGARE WATER CONDITIONER 1 may be used with all pesticide types when acidic conditions are acceptable. DIRECTIONS FOR USE

ALLIGARE WATER CONDITIONER 1 does not contain oil or surfactant but may be used in conjunction with these products. Use only with pesticides that allow low pH conditions. Do not use with copper-containing actives.

Follow the mixing procedure for the pesticide being used. While ALLIGARE WATER CONDITIONER 1 may be added at any time, it should be added after any wettable powders or other solid formulations have been thoroughly dispersed, for maximum efficacy.
