FIRST AID

IF SWALLOWED: Immediately call a poison center, doctor or physician. Unless advised otherwise by a poison control center or doctor, have person rinse mouth with water, if able. Do not give anything by mouth to an unconscious person. Do not induce vomiting. If vomiting occurs, keep head lower than hips to help prevent aspiration.

IF INHALED: If breathing is difficult, remove person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferably mouth to mouth if possible.

ALLIGARE FORESTRY OIL is an oil-based adjuvant specially designed for use with products that require or recommend an oil adjuvant be used. **ALLIGARE FORESTRY OIL** helps the active ingredient penetrate into plant tissue. The emulsification system of **ALLIGARE FORESTRY OIL** is designed to keep the oil mixed in water and help spread faster for a more even coverage and penetration.

USE RATES

For forestry, ditch-bank, utility, rights-of-ways and other applications use 1 to 4 pints of **ALLIGARE FORESTRY OIL** per acre. Site preparation products may require rates as high as 5 quarts per acre. Follow the recommendation of the pesticide used.

For Conifer Release: Use 3 oz. per 100 gallons for herbaceous, and 8 oz. per 100 gallons for woody conifers, when using 10 gallons per acre. Do not exceed 0.25% by spray volume for herbaceous conifer release, or 0.75% by spray volume for woody conifer release.

NOTE: Due to variations in water and other conditions, the optimum use rate may vary. Sufficient product should be added to allow an even deposit of the active chemical.

DIRECTIONS

NOT FOR AQUATIC USE

MIXING: Always follow herbicide label recommendations. If no recommendation is made, follow these directions: 1) Fill the tank 50% with water. 2) Start stirring. 3) Add all other tank mix partners including the active ingredient, per directions on the active label. 4) Add **ALLIGARE FORESTRY OIL** and agitate until thoroughly mixed.

ALLIGARE FORESTRY OIL may be used as a diluent oil for herbicides used as basal bark, directed or broadcast stem applications.

STORAGE: Store in a cool, dry place. Keep in original container tightly closed. Do not reuse empty container. Do not store with food, feed, or other material to be used or consumed by humans or animals. Do not contaminate water supplies. For optimal storage, store between 40° and 90° F.

***DO NOT USE, POUR, SPILL, OR STORE NEAR
HEAT OR OPEN FLAME.***

DISPOSAL: Do not contaminate water, food or feed by storage or disposal. Dispose of contents in container to an approved waste
