#### 4. FIRST AID MEASURES

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first five minutes, then continue rinsing eye. If eye irritation persists, call a poison control center or doctor for treatment advice.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. If skin irritation or rash occurs: call a poison control center or doctor for treatment advice.

#### 5. FIREFIGHTING MEASURES

#### 6. ACCIDENTAL RELEASE MEASURES

**Personal Precautions:** Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

**Small Spills:** Absorb using sand, vermiculite or other inert absorbent. Place contained material in appropriate container for disposal.

**Large Spills:** Dike spillage and recover and retain as much free liquid as possible for reuse using explosion-proof equipment. Pick up remainder with suitable absorbent material. #### 7. HANDLING AND STORAGE
